<b>Objectives / desired outcomes</b>	<ul style="list-style-type: none"> <li>• To make recommendations to CPR&amp;GSC / LLSC (as appropriate) to enable CPR&amp;GSC / LLSC to make recommendations in relation to the future use of the Groves School building;</li> <li>• To ensure that the Council, as owners of the listed Groves School building, explores all avenues for a future use to satisfy the statutory responsibilities and covenants.</li> </ul>
<b>Timescales / Time restraints</b>	<ul style="list-style-type: none"> <li>• There are no external time sensitivities or constraints;</li> <li>• At this time, given the processes involved in the marketing and planning issues related to the building and site, it is not possible to determine a final reporting date;</li> </ul>
<b>Define scope – what is included?</b>	<ul style="list-style-type: none"> <li>• Proposals for future use of the school building;</li> <li>• Proposals for future use of the Groves site in so far as this affects the potential for future use / redevelopment of the Groves building;</li> <li>• Oversight of the corporate processes involved in the development of future use of the school building;</li> <li>• Discussions with Head of Department Housing and Economy / Strategic Assets Lead; Lead Member - Education, Council Leader/Lead Member - Finance, Performance Health &amp; Safety and Governance</li> <li>• Consultation with community groups, partners, etc. as appropriate</li> </ul>
<b>Define scope – what is not included?</b>	<ul style="list-style-type: none"> <li>• Reconsideration of use of the building by the Education Department for Primary education.</li> </ul>
